

## Terms and Condition 2024 – Toshima City After-school Daycare Club

This facility is for children who are unable to receive proper care after school due to their guardian’s work, illness or other reason. If you live in Toshima City or are enrolled in a Toshima public elementary school and meet certain conditions, you can use the Club.

◆Eligibility requirements by guardian status are as follows.

In addition to the above conditions, it is limited to those who need to use 4 days or more per week on weekdays until 6 pm.

(\* 2) Not for 2 months

(\* 3) "Job Search Activity Report" is required at the time of renewal for primary earner.

\*Children with disability

- Children in 4th grade and above will also be screened under the same conditions of 3rd grade.
- Contact the After-school Daycare Club for other documents to be submitted.

\*If you wish to use the program only during the summer vacation, you may also apply if you meet the above qualifications.
