Those who are relevant to **all** $(1) \sim (3)$

- (1) Total income of whole household is within screening criteria (**See the list below for the amount)
- (2) Live in Toshima City when applying and will live after April 2024.
- (3) Children will enter national and public elementary school in April 2024
- *Even if your children plan to enter private elementary school as of now, you can apply. When your children decide to enter private elementary school, the admission allowance will not be paid.

The admission allowance will not be paid to those who are relevant to either of $(4) \sim (6)$.

- (4) Are receiving welfare (* It will be paid from welfare payment.)
- (5) Have already received the allowance at the other municipality.

- Please refer to the attached "Enrollment Confirmation Forms" and complete the necessary procedures by the due date. If your children wish to enroll in an elementary school in a city other than Toshima City, please contact us at the following address.
- ★Even if you are approved for an admission allowance this time, you will still need to apply for a school financial assistance (SFA) in April for the 2025 fiscal year, as an application is required each school year.
- ★Those who were not approved this time can apply for SFA for the 2025 fiscal year after April and would possibly be approved upon review ※.

※This application will be reviewed based on the total household income for the year 2023, but the application after April 2025 will be reviewed based on the total household income for the year 2024.

So be aware that the year for the total household income review will change.

If you are approved for SFA for the 2025 fiscal year, you can receive financial support of Admission Allowance and school supplies, etc.
